**IFRS 9: Finanzinstrumente - Klassifikation, Bewertung, Auswirkungen und Herausforderungen im Versicherungsunternehmen** Therese Tröger, 2017-05-22 Versicherungsunternehmen sind derzeit mit dem aktuellen Niedrigzinsumfeld und der Einführung von Solvency II Veränderungen ausgesetzt, die das Kapitalanlagegeschäft zunehmend beeinflussen. Hinzu kommt die Einführung des „IFRS 9: Financial Instruments“, der die bilanzielle Abbildung des Kapitalanlagegeschäftes der Versicherungsunternehmen neu regelt und die Geschäftstätigkeit der Versicherungsunternehmen zunehmend beeinträchtigen wird. Die Bilanzierung des Kapitalanlagegeschäftes der Versicherungsunternehmen geht derzeit vor allem auf den internationalen Rechnungslegungsstandard „IAS 39: Finanzinstrumente: Ansatz und Bewertung“ hervor. Seit 2005 beschäftigt sich das IASB mit der Neureformierung der Bilanzierung von Finanzinstrumenten. Nach der Finanzkrise und zahlreichen Diskussionspapieren wurde in 2014 der neue Standard zur Bilanzierung von Finanzinstrumenten veröffentlicht. Für Versicherungsunternehmen stellt sich die Frage, welche Auswirkungen und Herausforderungen IFRS 9 mit sich bringt und wie sie sich auf die Einführung dieses Standards vorbereiten können. Aus diesem Grund beschäftigt sich das vorliegende Werk insbesondere mit den bilanziellen Effekten, dem Ausnutzen potentieller Ermessensspielräume und den notwendigen Implementierungs- und Dokumentationsaufwand, der durch die Einführung von IFRS 9 entsteht.

**Die Umstellung von IAS 32/IAS 39 auf IFRS 9 in der internationalen Rechnungslegung: Chancen und Herausforderungen für die bilanzierenden Unternehmen** Tim Schebler, 2014-02 Für eine Vielzahl von Unternehmen, die nach IFRS bilanzieren, stellen sich in der heutigen Zeit diverse Fragen in Hinblick auf die Umsetzung der Vorschriften des internationalen Standardsetters, dem International Accounting Standards Board. Die in diesem Zusammenhang hervorzuhebende Problematik betrifft die Bilanzierung von Finanzinstrumenten. Der Ansatz und die Bewertung dieser Finanzinstrumente werden in den IFRS momentan durch die Standards IAS 32 und IAS 39 geregelt. Doch eben bei der Anwendung dieser Standards kommt es bei den bilanzierenden Unternehmen aufgrund der Komplexität der Vorschriften zu

Problemen und einem erhöhten Mehraufwand. Allerdings ist die Komplexität der momentanen Vorschriften nicht nur den Unternehmen selbst bekannt, sondern auch dem Standardsetter IASB. Eine der grundlegendsten Überarbeitungen des IAS 39 wurde im Jahr 2003 vorgenommen. Selbst nach dieser Neuordnung der Bilanzierung von Finanzinstrumenten nach IFRS kam es zu weiteren Änderungen und Interpretationsansätzen. Insbesondere der außerordentlich lang andauernde Anerkennungsprozess des Standards durch die EU, die diesen erst im Jahr 2005 ratifizierte, führte bei den anwendenden Unternehmen zu einer wachsenden Verunsicherung, da sich durch die Vielzahl von Änderungen häufig neue Fragestellungen ergaben und sich die erwünschte Reduktion der Komplexität der Vorschriften daher nur schrittweise erreichen ließ. Nach der endgültigen Verabschiedung des IAS 39 durch die EU Kommission kam die Diskussion bezüglich der gültigen Bilanzierungsvorschriften für Finanzinstrumente allerdings nicht zum Erliegen. Besonders bedingt durch die weltweite Krise der Finanzmärkte geriet der IAS 39 abermals in die Kritik. So proklamierten eine Reihe von Wirtschaftswissenschaftlern, Praktikern und vor allem Politikern die These, dass der in den Vorschriften des IAS 39 enthaltene Ansatz der Fair-Value Bewertung von finanziellen Vermögenswerten, einen entscheidenden Anteil am Ausbruch und der Ausweitung der Finanzmarktkrise trage. Dabei wurde vor allem von der Politik Druck gegenüber dem IASB ausgeübt, die bestehenden Regelungen zu überarbeiten. Dieser Umstand wurde zum Anlass genommen, die Ablösung des IAS 39 durch die Entwicklung eines neuen Standards einzuleiten. Die verpflichtende Anwendung der Vorschriften des IFRS 9 ist für alle nichteuropäischen Unternehmen auf den 01. Januar 2015 terminiert. Ab wann in diesem Zusammenhang auch die Unternehmen in der EU verpflichtet werden, die neuen Vorschriften anzuwenden, bleibt offen, da das EFRAG beabsichtigt, die Ratifizierung der Vorschriften des IFRS 9 erst dann durchzuführen, wenn das Reformprojekt der Bilanzierung von Finanzinstrumenten vollständig abgeschlossen ist.

Während dieser Zeit wurde der IAS 39 wegen seiner Komplexität vielfach kritisiert und mehrfach überarbeitet. Ebenfalls kam es durch das Harmonisierungsprojekt der International Financial Reporting Standards (IFRS) und den United States Generally Accepted Accounting Principles (US-GAAP) zur Anpassung des Standards. Durch den Ausbruch der Finanzkrise rückte der Rechnungslegungsstandard IAS 39 erneut in den Fokus der Politik. Die Group of Twenty (G20), die aus Finanzministern und Zentralbankpräsidenten besteht, forderte die internationalen Standardsetzer zu einer Überarbeitung der Bilanzierung von Finanzinstrumenten auf. Die Anwendung dieser Neuerungen des IFRS 9 wird für die nichteuropäische Finanzindustrie ab dem 01. Januar 2015 verpflichtend sein. Eine vorzeitige Anwendung ist auf freiwilliger Basis bereits vorher erlaubt. Von diesem Wahlrecht wurde von nichteuropäischen Finanzinstituten in der Praxis bereits vereinzelt Gebrauch gemacht. Eine Übernahme des IFRS 9 in europäisches Recht ist derzeit von der Kommission der Europäischen Union (EU-Kommission) noch nicht zeitlich determiniert. Am 24. Juli 2014 hat der IASB den internationalen Rechnungslegungsstandard IFRS 9 Finanzinstrumente veröffentlicht. Der neue Standard ist verpflichtend auf Geschäftsjahre anzuwenden, die am oder nach dem 1. Jänner 2018 beginnen. Die Ablöse des vormals gültigen IAS 39 Finanzinstrumente: Ansatz und Bewertung geht mit signifikanten Umstellungseffekten einher, die insbesondere bei Kreditinstituten zu Veränderungen in der Bilanzierung, Bewertung und Berichterstattung führen. Sämtliche Bereiche eines Finanzdienstleistungsunternehmens müssen bei der Umstellung miteinbezogen werden angefangen von der Bilanzierung, dem Risikomanagement, dem Controlling und Organisation bis hin zur kostenintensiven Anpassung der IT-Landschaft. Inhaltlich gesehen umfasst die Umstellung unter anderem die Neuklassifizierung von Finanzinstrumenten anhand des Geschäftsmodells und dem Zahlungsstromkriterium sowie die geänderten Vorschriften zur Erfassung von Wertminderungen. On July 24, 2014, the IASB published IFRS 9 - Financial Instruments. The new standard is mandatory for fiscal years beginning on or after 1st of January 2018. The replacement of the previously valid IAS 39 Financial Instruments: Recognition and Measurement is accompanied by significant conversion effects, which in particular lead to changes in accounting, valuation and reporting at banks. All areas of a bank need to be involved in the transition. This involves the departments accounting, risk management, controlling and organization and leads further to a cost-intensive adaptation of the IT landscape. In terms of content, the change includes among other things, the reclassification of financial instruments based on the business model and the cash flow criterion as well as the amended provisions for recognizing impairment losses. In addition IFRS 9 specifies regulations for the reclassification of financial instruments. The objective of this paper is to demonstrate the new depth of regulation of IFRS 9. A major change is the conversion of the valuation concept from incurred to expected credit losses, those changes build the scope of this paper. For this purpose a possible calculation method, as used in banks, is presented. Further the corresponding implementation requirements are introduced. Although the IASB's objective to reduce the complexity of the standard has been complied with, lot of room for interpretation has been left which will be discussed in the context of this paper.
